PROPERTY & LIABILITY TERMINOLOGY

- 1. AMERICANS WITH DISABILITIES ACT (ADA) A federal act designed to set standards to remove the barriers to employment, transportation, public accommodations, public services, and telecommunications that exist for those members of our society who have physical disabilities. The act encompasses aspects of everyday life and generates wide ranging implications for almost every business or service.
- 2. CIVIL RIGHTS VIOLATIONS The term applied to tort claims involving issues of sexual harassment; wrongful termination; employment, age, gender or race discrimination; ADA; employment harassment. If Plaintiff prevails, even partially, this type of case entitles plaintiff to also collect attorney fees.
- 3. CLAIM TYPES The internal coding systems for claims includes:

ABI – Auto Bodily Injury	BM – Boiler/Machinery	LPI – Liability Personal Injury
ACL – Auto Collision	CF – Crime/Fidelity	LPD–Liability Property Damage
ACP – Auto Comprehension	EP – Liability Employment Practices	P – Property
AGK – Auto Garage Keepers	LBI – Liability Bodily Injury	SE – Special Education
APD – Auto Property Damage	LEO – Liability Errors & Omission	SM – Liability – Sexual Misconduct

- 4. CLASS ACTION A lawsuit in which one person or a small group of people represent the interests of an entire class of people in litigation.
- 5. COMPARATIVE NEGLIGENCE A more modern system of allocating damages between two or more persons than the method of contributory negligence. Under comparative negligence, the damages collectible in relation to another person are diminished in proportion to one's degree of negligence. In most instances, damages cannot be collected at all if the claimant's negligence were greater than that of the other party. Currently, in a few instances, the courts have awarded both parties damages as a percent of the total damages, depending on respective degrees of fault.
- 6. **CROSS COMPLAINT** A claim asserted by a defendant against another party to the action. Also termed (in some jurisdictions) *cross petition*. A claim asserted by a defendant against a person not a party to the action for a matter relating to the subject of the action.
- 7. DECLARATORY RELIEF ACTION Remedy for the determination of a judicial controversy where a plaintiff or defendant is in doubt as to their legal rights. No consequential relief is awarded.
- 8. ERRORS AND OMISSIONS (E&O) A form of Professional Liability insurance which provides coverage for mistakes made in a profession not involved with the human body (lawyers, architects, engineers) or for mistakes made in a service business (insurance, real estate, and others). Also a form of coverage for financial institutions protecting against loss to lending institutions which fail to effect insurance coverage.
- 9. HEARSAY Testimony by a witness based not on his or her own observations but on what someone else said, offered in evidence to prove the truth of what was said.
- 10. HOLD HARMLESS AGREEMENT A contractual arrangement whereby one party assumes the liability Inherent in a situation, thereby relieving the other party of responsibility. Such agreements are typically found in leases and easements and construction contract agreements. Agreement or contract in which one party agrees to hold the other without responsibility for damage or other liability arising out of the transaction involved.
- 11. INCURRED LOSSES The amount equal to paid losses and losses for which the insurer is liable but has not yet paid.
- 12. INJUNCTIVE RELIEF ACTION Legal action filed for prohibitive or equitable relief. An action filed to forbid an act or to restrain someone from continuing an act which is considered unjust or injurious.
- 13. MORAL HAZARD A condition that may lead a person to intentionally cause or exaggerate a loss.
- 14. **MOTION FOR SUMMARY JUDGMENT** Rule of civil procedure permitting either side in a civil suit to move for dismissal when it is believed that there is no genuine issue of material fact that would allow the other side to prevail as a matter of law. The "motion" may include all or part of a claim.
- 15. MOTION IN LIMINE A pretrial request that certain inadmissible evidence not be referred to or offered at trial.
- 16. PERSONAL INJURY Injury, other than bodily injury, results from oral or written communication.
- 17. **PUNITIVE DAMAGES (Exemplary)** Damages awarded separately and in addition to compensatory damages, usually on account of malicious or wanton misconduct, to serve as a punishment for the wrongdoer and, possibly, as a deterrent to others. Sometimes referred to as "exemplary damages" when intended to "make an example" of the wrongdoer. By law, government entities are immune from punitive damages.
- 18. **RESERVATION OF RIGHTS LETTER** An insurer's letter that specifies coverage issues and informs the insured that the insurer is handling a claim with the understanding that the insurer may later deny coverage should the facts warrant it.
- 19. SUBROGATION In insurance, the substitution of one party (insurer) for another party (insured) to pursue any rights the insured may have against a third party liable for a loss paid by the insurer.
- 20. **TORT** A legal wrong arising from a breach of duty fixed by law, except under contract, causing injury to persons or property and redressible by legal action for damages. Government entities are ruled by the Tort Claims Act.
- 21. VENUE The locale in which the lawsuit may be brought.

The Board went into closed session at 10:31 a.m.

Reconvene to Open Session

The Board reconvened into open session at 10:55 a.m.

With respect to the claim filed by L.O. (a minor) against Fruitvale School District after discussion, motion was made by Director Bryson, seconded by Director Russell and by roll call vote of 9-0-0 the board approved the payment of \$115,000 for the settlement of this claim with L.O. (a minor).

With respect to the claim filed by Alpine Unified School District after discussion, motion was made by Director Hughes, seconded by Director Phinney and by roll call vote of 9-0-0 the board approved the payment of \$29,948.90 for supplemental damage discovered to building and HVAC system due to a storm.

With respect to the claim filed by Panama Buena Vista Union School District after discussion, motion was made by Director Lemon, seconded by Director Pawlowski and by roll call vote of 8-0-1 (abstention by Director Russell) the board approved the payment of \$62,913.65 for repair to portable classroom due to fire caused by arson.

With respect to the claim filed by Abel Davila against Delano Joint Union High School District after discussion, motion was made by Director Bryson, seconded by Director Hedge and by roll call vote of 9-0-0 the board approved the settlement authority of \$200.000.00 for the settlement of this claim with Abel Davila.

With respect to the claim filed by Jonisha Holden against Palmdale School District after discussion, motion was made by Director Hedge, seconded by Director Lemon and by roll call vote of 9-0-0 the board approved the payment of \$80,000.00 for the settlement of this claim with Jonisha Holden.

Action Items

Report of Property and Liability Claims – November 2024

Robert Kretzmer presented the Report of Property and Liability Claims. There were 52 new claims, 85 claims were closed and no claims reopened in November, resulting in 556 pending claims. Robert reviewed the check register for November 2024, reporting on nine checks that were in excess of \$50,000.00. After discussion, motion was made by Director Russell, seconded by Director Pawlowski and by roll call vote of 9-0-0, approving payment of Property and Liability Claims in the amount of \$3,069,091.88 for the month of November 2024.

Financial Report

Megan Hanson reviewed with the Board the Financial Report for the period ending November 30, 2024. Megan reported the LAIF rate for the month of November 2024 dropped to 4.48% from last month at 4.52%. After discussion, motion was made by Director Phinney, seconded by Director Hughes and by roll call vote of 9-0-0, approving the Financial Reports as submitted.

Approval of Excess Property Insurance Rate Renewal for 2025

Megan Hanson reviewed with the Board the Excess Property Renewal for 2025. Megan reported that there would be a decrease in the rate from the previous year. After discussion, motion was made by Director Lemon, seconded by Director Hughes and by roll call vote of 9-0-0, approving the Property Insurance Rate Renewal for 2025.

Robert Kretzmer discussed the total insured value report completed by Randye Rogers and Centerisk with the Board.

Property Loss Reporting

Ryan Bourget discussed the property loss report with the Board. Ryan also reviewed the steps when reporting a loss.

Robert Kretzmer introduced Ashley Moland as the new lead claims examiner for the Property & Liability Program.

U.S. Chamber of Commerce Update on Nuclear Verdicts

Robert Kretzmer reviewed an article on Nuclear Verdicts with the Board.

Quarterly Update

2024 DEFENSE COUNSEL SUMMIT

This year's Defense Counsel Summit included a look back and a look forward at significant issues in school district litigation. Caren Curtiss with Herr Pedersen and Berglund provided a detail history of Code of Civil Procedure (CCP)340.1. This is the code that deals with childhood sexual abuse and how the parameters for reporting and filing suit have changed over the years. Curtiss reviewed the legislation introduced in 1985 and how it has changed over the years, with the last modification in 2023. The document Curtiss prepared as part of this presentation is available on our website sisc.kern.org/pl/ under Articles and Documents of Interest.

A look back at the legislative year and bills that have passed or were proposed was provided by Faith Borges, with Actum, LLC. Borges shared which bills will impact school districts and the litigation landscape. Assembly Bill 1913 signed by Governor Newsom becomes effective 7-1-25 and requires school districts to incorporate training on recognizing childhood sexual abuse as part of the Child Abuse and Neglect Report Act (CANRA) training that school district employees must complete annually as part of their mandated reporter responsibilities.

Golnar Fozi, Attorney with Fozi Dwork & Modafferi, LLP provided information on current trends in employment litigation and included the opportunity for questions. This was an important opportunity for defense counsel members to discuss what they are seeing in defending employment litigation claims, and how districts can implement practices to reduce these types of claims.

Also included was a panel discussion on the current landscape in California education and what they see for the future. Panel members included Michael Fine, Chief Executive Officer, Fiscal Crisis Management Assistance Team (FCMAT), David George, CEO of Schools Excess Liability Fund (SELF), Anthony DeMaria, Owner/ Attorney, DeMaria Law Firm, Dr. John Mendiburu, Superintendent of the Kern County Superintendent of Schools Office. The panelists discussed the impact of legislative changes on the education landscape, insurance coverage and fiscal stability. State leaders are monitoring birth rates, legislative changes, staff turnover and retirement, and its impact on California school districts. In addition, the panel discussed the opportunities to improve the landscape in their respective areas and how educational entities must evolve and explore new opportunities to expand educational opportunities to meet the social, emotional, and educational outcomes for children in our evolving world.

2025 Property Appraisal Scheduled

SISC has contracted with Centurisk (formerly AssetWorks Risk Management) to provide property appraisal services for our member districts.

These services include onsite inspections and valuation of buildings with a value of \$1 million or greater. These inspections will be scheduled in a 5-year cycle.

Centurisk will be scheduling inspections in January and February for our member districts in the following counties:

- Calaveras County
- Fresno County
- Inyo County
- Kings County
- Madera County
- Merced County
- Mono County
- San Joaquin County
- Tulare County
- Tuolumne County

AHERA MANAGEMENT PLANS

The Environmental Protection Agency enacted the Asbestos Hazard Emergency Response Act (AHERA) in 1987. AHERA applies to all K-12 public and private schools. Briefly, districts must inspect and identify suspect asbestos containing building material, conduct periodic surveillance of the material and maintain a management plan. While many districts have abated suspect building materials through modernization projects, some sites still have building material that is being monitored.

The SISC Property and Liability Safety and Loss Control Specialists provide the following AHERA asbestos services to member districts:

- Maintaining the management plan on a computer database.
- Performing the required three-year re-inspections.
- Updating the management plan pursuant to inspection results.
- Providing employee training pursuant to AHERA.
- Advising districts regarding compliance issues.

Although the SISC Property and Liability safety staff offers a valuable service, it is important to note that your district has responsibilities regarding AHERA compliance. Some of those responsibilities include the following:

- Selecting and training an appropriate "designated person" to implement the AHERA requirements.
- Notifying employees, parents and contractors of the presence of the district's management plan.
- Tracking new construction and obtaining documentation from architects and contractors regarding certification of asbestos-free construction.
- Obtaining documentation that new materials installed in buildings do not contain asbestos.
- Maintaining documentation of all abatement projects and archived management plans.
- Making sure all six-month asbestos inspections are performed and kept in a permanent file.

Please be aware that SISC Property and Liability safety staff will always strive to provide service regarding AHERA compliance; however, our job is dependent on, and limited to, the active participation of each member district. SISC cannot be responsible for districts that do not fulfill their compliance responsibilities. It is by working together that we can produce a viable management plan.
